



## Fuel Voucher Rewards

### AETOS Professional Account Time-limited Promotion

#### Terms and Conditions

#### 1. PROMOTION

AETOS Capital Group Pty Ltd (“**AETOS**”, “**we**”, “**us**”) offers the promotion defined hereunder to clients who trade with AETOS Professional Account (“**You**”).

Subject to these terms and conditions, you may be entitled to receive one fuel values up to \$888 when you meet the required deposit and trading volume during the Promotion Period.

#### 2. PROMOTION PERIOD

The promotion starts on 01 May, 2022 at 00:00 AEST and ends on 30 June, 2022 at 11:59 AEST (the “**Promotion Period**”).

#### 3. ELIGIBILITIES

**To be eligible to participate in the Promotion, You must:**

- (a) be a natural person;
- (b) be over eighteen years of age;
- (c) be a resident of Australia;
- (d) be qualified as either Wholesale Clients or Sophisticated Investors; (“**Eligible Client**”)
- (e) have opened a Professional Account with AETOS and such accounts are always subject to AETOS Terms and Conditions and not subject to any dispute or default. Meanwhile, such accounts must also meet the deposit and required trading volume requirements within 1 month since the deposit top-up date (existing clients) or account activation date (new clients); (“**Eligible Account**”)
- (f) Agree and comply with these Promotion Terms.

**(Collectively, the “Eligibility Requirements”)**

#### 4. THE DEPOSIT AND TRADING VOLUME REQUIREMENTS

- 4.1** To be eligible to claim your fuel voucher, you must make a deposit\* at least of \$2,000 in an equivalent amount of the account currency, which is either AUD or USD. New clients must make such a deposit within one calendar day<sup>##</sup> upon your Professional Account being activated and existing clients could satisfy the deposit requirement by making a new top-up during the Promotion Period.



## One calendar day means the time period from 22:00 GMT of the previous day to 21:59 GMT of the current day (Daylight Saving Time). For example, the calendar day of 3<sup>rd</sup> November, 2020 is from 22:00 GMT, 2<sup>nd</sup> November, 2020 to 21:59 GMT, 3<sup>rd</sup> November, 2020.

- 4.2** On top of the deposit requirement, all participants must also meet the required trading volume criteria set out in the table below within 1 month from the date of making the required deposit (existing clients) or account activation date (new clients).

#### **4.3 Trading Volume Requirement**

- 4.3.1 The trading volume is calculated as per closed trade.
- 4.3.2 Eligible Account needs to meet trading volume criteria within 1 month period since you satisfy the deposit requirement.
- 4.3.3 Each level of trading volume requirement corresponds with its respective deposit criteria and fuel voucher value.
- 4.3.4 The trading volume is calculated for Eligible Account only.
- 4.3.5 For clients who own multiple trading accounts with AETOS, only one account under the same account holder is eligible for the Promotion. DO NOT aggregate the total trading volumes and deposits across multiple accounts.
- 4.3.6 **The trading volume calculation will not include Share CFDs and Cryptocurrency CFDs.**

#### **4.4 Deposit Criteria**

- 4.4.1 Only deposits made from external sources are taken into consideration. Internal transfer

from any other account held by the Eligible Clients to participate in this promotion will not be calculated.

4.4.2 The deposits made by Eligible Clients to meet the Deposits Criteria of the Promotion may incur minor difference from the clear fund AETOS received due to bank commission charges. The deposit will be calculated according to the actual clear fund AETOS received,

4.4.3 Before you make your claim for the fuel voucher by completing the required trading volume, if any deposit withdrawal or transfer request from you, the deposit amount will be recalculated by deducting the withdrawal or transferred amount. The trading volume will also be calculated according to the actual deposit criteria that you have met.

**5. \$ refers to the currency that Your account is denominated in, which is either AUD or USD.**

**6. The promotion is available for AETOS Professional Account only.**

**7. Only one account is eligible to participate in the Promotion per Eligible Account holder. Each Eligible Account holder can claim for fuel voucher one time when meets the deposit and trading volume requirements. Once the voucher is redeemed, the Promotion for the account holder will be terminated by default.**

## **8. HOW TO REDEEM THE FUEL VOUCHER**

8.1 To claim the fuel voucher, in the condition that you have already met the aforementioned deposit and trading volume within the required period, you must send a request from Your AETOS registered email to [funding@aetoscg.com](mailto:funding@aetoscg.com).

8.2 Upon receiving the claim request, AETOS will review and confirm if you have met all Eligibility Requirements.

8.3 After review and confirm that the account satisfied the eligibility requirements, AETOS shall send the voucher to you.

8.4 Once we send the voucher to the registered email (digital format) or to registered address (by post), it is deemed as being delivered once we send it out. You will be solely responsible for the correct information provided to us for voucher claim purpose.

8.5 No list of petrol station brands for participants to choose from. AETOS will arrange the purchase and sending of the fuel card and reserve the right of final decision on the choice of fuel card.

## **10. Liability**

- 10.2 To the extent permitted by law, your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and You expressly waive any and all such rights.
