



## W-8BEN INDIVIDUALS FORM TO CLAIM US TAX TREATY BENEFITS

### HOW TO COMPLETE YOUR W-8BEN FORM

**Please note:**

1. U.S. Share CFD investors should complete the form.
2. The W-8BEN form can only be completed by a non-U.S. person.
3. The W-8BEN form will be valid for a period starting on the date the form is signed and ending on the last date of the third succeeding calendar year.
4. Should any change happen to your tax residency after the submission of the form, please notify AETOS of the change.
5. By following the requirements by U.S. authority, the form should be completed with a handwritten signature, otherwise an electronic signature with a time and date stamp and statement that the form has been electronically signed is also acceptable.
6. The form must be completed correctly without any amendments. Please use a new form instead if a mistake made.
7. All Date should be put down in US Date format (MM-DD-YYYY).
8. Line 5 leave blank if you are a non-U.S. person
9. Line 6, check 6b if you are an Australian tax resident
10. Line 9, put down "Australia" if you are an Australian tax resident. You may refer to ATO website if you are not sure about your tax residency.
